OPEN ESTONIA FOUNDATION IN 1995

The Open Estonia Foundation, founded on the initiative of George Soros, a well-known US businessman and philanthrophist, celebrated its fifth anniversary in 1995.

The Open Estonia Foundation is a non-governmental charitable foundation with the aim of developing an open society, i. e. a society where freedom of expression, democracy and the rule of law are guaranteed. In order to achieve this, we have directed our efforts towards supporting various activities and ideas related to the concept of an open society in the fields of education, culture, law, minorities, human rights, not-for-profit sector and information systems.

The activities of the OEF may be divided into two. On the one hand we work on several international and pro-active programmes, aimed at bringing new ideas and experiences to Estonia. On the other hand we support local initiatives which aim to broaden local understanding of civil society.

In 1995 the Open Estonia Foundation awarded grants with a total value of **35.5 million** Estonian kroons. The breakdown of grants was as follows:

49% - education (higher and secondary education, scholarships and internships)

11% - civil society development programmes (human rights, culture and education of minorities, non-governmental organisations and the not-for profit sector)

- 8% library
- 6% art and culture
- 6% Internet

4% - East-East programme supporting the co-operation of Central and Eastern European countries

- 3% legal reform
- 3% public administration
- 2% media
- 2% medicine
- 2% economy
- 2% publishing
- 2% conference and travel

The priorities of the OEF in 1995 were educational reform in schools and universities, teaching the Estonian language to the non-Estonian population, publishing the works of Western philosophers and law textbooks, legal and fiscal regulation of the not-for-profit sector, public administration, the Internet and the establishment of a youth education fund, SOS-Estonia.

The Open Estonia Foundation finances a lot of programmes together with local and foreign organisations. Still we hope that the work of our foundation will help us in finding additional benefactors and that the role of local support for the idea of the open society will increase. We must be aware that the existence of the open society in Estonia is of vital importance.

In April 1995 the Open Estonia Foundation celebrated its fifth anniversary.

Looking back over those five years it can be seen that the OEF has 'matured' very quickly and has successfully operated as a supporter of the idea of an open society. In 1995, the budget of the OEF increased remarkably, having a total value of 35.5 million Estonian kroons.

Established traditions also show the maturity of the OEF. From 1992 to 1995, the OEF has four times awarded the Independence Day Award at an annual ceremony with the aim of recognizing the lifetime work of those people who had the courage and strength to maintain their spiritual independency and mental vitality during the hard times. So far the Award has been given to linguist Pent Nurmekund (1992), art historian Villem Raam (1993), bibliographer Endel Annus (1994), philologist Juhan Peegel (1994), organist Hugo Lepnurm (1994), translator Rein Sepp (1994), artist Olga Terri (1995), literary scientist and translator Oskar Kuningas (1995) and to a well-known doctor, Harri Kruuse (1995), all of whom are remarkable personalities and have deserved our honour and respect.

One of the reasons for the success of the OEF is the work of the Board and the staff. Several former Board members cooperate with the OEF as experts or councillors. For example, take the contribution of Professor Richard Villems, Jaak Lippmaa and Professor Igor Černov.

When speaking about the activities of the Foundation, we cannot avoid the issue of the future of the OEF. The aim is to find local sources of funding since the support of Mr Soros will not last forever. The progress of the Estonian economy and society has been extensive and we believe that in the course of the development of particular legislation and by acknowledging the needs of a society and the importance of philanthropy several local donors in favour of the idea of an open society will appear.

Looking at the coming year, we expect people to approach us with bright, new ideas within the fields of culture, education and civil society, ideas which will enable us to step bravely into the next millenium.

Open Estonia Foundation and George Soros

George Soros was born on August 12 1930 in Budapest. He emigrated to England in 1947 and graduated from the London School of Economics. In 1956, he moved to the United States where he founded his own company Quantum Fund in 1969 after years of experience on Wall Street.

At present, Mr Soros is the President of Soros Fund Management, and Chief Investment Advisor to Quantum Fund though giving most of his time to philanthropy. As a total opponent of closed societies, George Soros has followed the reforms in Central and Eastern European countries closely. He founded the Open Society Fund, New York, in 1979 and the Soros Foundation, Hungary, in 1984.

Mr Soros is also the founder of the Central European University in Budapest and Warsaw which offers postgraduate programmes in economics, international relations, political science, sociology, history, law, medieval studies and environmental science. George Soros also founded the Open Society Institutes in New York and Budapest, the Institute of Local Government and Public Service in Budapest, the Open media Research Institute, Prague, and the Institute of Constitutional and Legislative Policy, Budapest.

The East - East programme, initiated in 1989, enables all Soros foundations to jointly fund a variety of projects which involve co-operation between Eastern European countries. An effort is being made to develop an intellectual common market in order to exchange experience and find solutions to similar problems.

In addition to many articles on the political and economic changes in eastern Europe, Mr Soros is the author of four books: *The Alchemy of Finance* (published in 1987), *Opening the Soviet System*, (1990), *Underwriting Democracy*, (1991), and *Soros on Soros* (1995).

George Soros has received honorary doctoral degrees from the New School for Social Research, New York, the University of Oxford, Budapest University of Economics and Yale University. Mr Soros has also been awarded high honorary prizes from the Republic of Hungary and Lithuania.

The Open Estonia Foundation was founded with the support of George Soros in 1990. At present, Mr Soros has a network of foundations operating in 24 countries in Central and Eastern Europe, South Africa, Haiti and the United States.

The aim of the Open Estonia Foundation is to direct the development of an open Society in Estonia. As of today, the Foundation has awarded grants to the sum of 85 million EEK in the fields of education, culture and civil society.

George Soros has said: 'In the last five years I have devoted much of my time, energy, and money to Central and Eastern Europe, because I believe that the collapse of the Soviet system was a historic, revolutionary event and the fate of the region will determine the fate of our civilization. I established a network of foundations whose aim is to promote and assist the transition from a closed to an open society. ... I have always been aware of a fatal weakness in the concept of an open society. The weakness is that people living in an open society seldom even recognize its existence, let alone treat open society as a desirable goal for which it is worth striving and making sacrifices. In one way, freedom is like the air: people struggle for it only when they are deprived of it. When it is there, they ignore it. But, in another way, freedom is very different; if you do not care for it, and do not protect it, it has a tendency to disappear.

The bottom line in the work of my foundations it to empower people who will make the sacrifices necessary to build open societies and who will care for and protect the freedoms they obtain for coming generations.'.

OEF INITIATIVES:

I. SEMINARS FOR SCHOOL LEADERS

The project launched a series of seminars for school leaders on the issues of pedagogical and administrative development, managing changes and evaluation, inviting 50 school teams (both directors and teachers) and using the 'know-how' acquired by the participants of the 1994 seminars, as well as the foreign consultants. The training programme consisted of 3 seminar periods, experts came from Great Britain, Sweden and Finland.

2. TRAINING THE CURRICULUM CONSULTANTS

The project derives from the need to train teachers in developing and implementing new school curriculae. The schools participating in the *Schools With Distinction* programme have all launched their own development work.

3. EVALUATION OF THE ACHIEVEMENTS OF SCHOOL WORK

The goal of the project was to work out the methodology of how to evaluate the achievements of school work. On the basis of analyzing the achievements of 15 experimental schools, and in co-operation with Tallinn Pedagogical University and State School Board, a set of materials was worked out as a handbook for school work evaluation, which also serves as the preparation for state quality control system. **EEK 116 425.00**

4. DEVELOPMENT OF SCHOOLS WITH DISTANCE EDUCATION CENTRES

The project provided methodological training on distance education to representatives of schools and universities, who are prepared as tutors and teachers for the inservice training project on education theory and evaluation, as well as other inservice training projects on curriculum innovations to be launched in their region.

5. DEVELOPING SUBJECT COURSES IN GRAMMAR SCHOOLS

The project experimentally launched the development of the system of subject courses and monitoring in selected pilot schools. The traditional system is not in accordance with the need to bring up independent young people, able to accept decisions and contribute to the formation of the essence of education. The project created a system where it is possible to select not only the academic subject cycles, but also the modules with the focus of vocational training.

6. PROBLEMATIC CHILDREN

One of the most painful problems in the contemporary Estonian schools is the ever increasing 'dropping out' from the schools. Many children do not develop at the same speed as the class according to the requirements of the curriculum. The goal of the project was to find methods of helping problematic children. **EEK 237 557.00**

7. EFFECTIVE SMALL SCHOOLS

The project brought together representatives of 25 small rural schools to analyze their problems and work out ways of improving their effectiveness. Methodological material was compiled on the issue. **EEK 196 300.00**

8. NEW CURRICULUM FOR RUSSIAN SPEAKING SCHOOLS

In the Russian schools of Estonia there is a lack of contemporary methodological literature on school and curriculum development. The goal of the project was to distribute contemporary pedagogical ideas and methods of innovation theory and team work, while working out the new curricula considering the tendencies and interests of Russian speaking schools in Estonia.

9. ACTIVE LEARNING INTO ACTION

Active learning methodologies have become increasingly popular in recent years. Still, most of the teaching in Estonian schools and universities is carried out in the classical lecturing style with the ultimate aim of having learners repeat material parrot fashion. In 1994, the new methods were introduced to achieve this aim of introducing a list of new methods into the most conservative part of the society – education – the idea of combining active methods with modern computer and telecommunicaton based techniques was worked out by a team of professionals from Estonian universities.

10. SCIENCE EDUCATION CURRICULUM

A new Science Education Curriculum is being developed by a Tartu University team for secondary schools under the auspices of the general education reform effort. Integrated science approaches allow students to find common themes among the major branches of science as they appear in the natural world. As a result students will be able to make connections between the disciplines of physics, chemistry and biology in addition to learning the logic of each discipline.

11. ECONOMIC EDUCATION PLANNING SEMINAR

The seminar brought together key economic education teachers from the NIS countries and the Baltics to evaluate progress, share experience, outline goals and plan for future collaboration. **EEK 195 775.00**

12. FOCAL POINTS IN MODERN EDUCATIONAL DEVELOPMENT

The project was designed for training those officials of Universities and the State School Board who are directly responsible for compiling the new curriculum. In the course of 3 seminars, issues of critical thinking, sustainable development in education and the modular curriculum and its development were discussed. **EEK 163 800.00**

13. TEACHER TRAINING IN CRITICAL THINKING AND ACTIVE LEARNING METHODS

The aim of the project was to develop a manual of 'Active Learning Methods' in cooperation with Estonian educators and the Education Development Centre (USA), which will be the basis of teacher training to be conducted afterwards.

14. STEP BY STEP

21 kindergartens all over Estonia are working according to the 'Soros Pre-school Programme'. All the managers and teachers' assistants are trained at weekly workshops and at major seminars convened by Estonian as well as by American Master Teacher Trainers. More than 500 families are engaged in the programme, all the kindergartens are equipped with special furniture, toys and study aids. The 'Soros Pre-school Programme' is translated into Estonian and introduced to most of the kindergartens in Estonia. The Ministery of Education has approved the programme as an alternative choice for kindergartens. A conference on Parent Involvement has been carried out, work is going on to establish a special course of Head Start methodology at Tallinn Pedagogical University and Tartu Pedagogical School.

15. HEALTH EDUCATION

In 1995, a special stress was laid on the work with Russian schools in Estonia. Two seminars have been run for teachers of Russian schools to introduce the Health Education Curriculum in Russian, the manuals in Russian have been delivered to them. 'The Environmental Education' manual has been translated from English and will be printed with financial help from the Ministery of Social Affairs of Estonia. **EEK 205 860.00**

16. HIGH SCHOOL DEBATE PROGRAMME

After establishing the Estonian Debate Centre at Tallinn Pedagogical University, a number of workshops have been run for teachers of secondary schools. The original textbook, 'Rhetorics and Debate', is being published, the State School Board has accepted the programme for Estonian secondary schools. A Debate Camp is being organized for students by the Debate Centre.

17. STUDENTS' ADVICE CENTRES AT TARTU UNIVERSITY AND TALLINN TECHNICAL UNIVER-SITY

For the 3rd year, the Open Estonia Foundation is supporting the activities of the Students' Advice Centres , which carry out outreach activities and organize conferences, orientations and workshops for high school students, undergraduate and graduates. Both centres publish newsletters dealing with international education and provide information about and application forms for OEF programmes, IREX and several other educational organizations. Tartu Centre helps USIS Tallinn to administer the Fulbright Program in Estonia. The centres also administer TOEFL, G-MAT and GRE tests.

18. SOROS INTERNATIONAL HOUSE - TALLINN

Soros International House opened with considerable financial support (100 000.00 USD) from the Open Estonia Foundation in January 1993 with 2 teachers from Great Britain. Since then it has expanded to its current size of 9 teachers, 1 Director of Studies and an Assistant Director teaching English to 21 different levels. Occasionally classes for children and Business English, as well as courses for teachers of English are held.

I. BETTER TEACHER – BETTER SCHOOL

The International Pedagogical Conference, organized by one of the rural schools of Estonia with participation of school delegations from the Baltics, Norway, Finland, the Netherlands and Sweden. **EEK 35 000.00**

2. MY SCHOOL - BOOK II

An original textbook for the first year of primary school, based on development biology and psychology, containing a lot of drawings to introduce 'picture model teaching' methodology. **EEK 10 000.00**

3. A HISTORY TEXTBOOK 'THE BALTIC STATES'

The aim of the project is to compile a common history textbook of the Baltic States. In the course of seminars, Estonian, Latvian and Lithuanian teachers of history work on common features of the three states. The textbook will be published in the three languages and in English.

4. RÄPINA SCHOOL OF AESTHETICS

The aim is to give a small town an equal opportunity with cities to educate children in psychology, art and music, manners, rhetorics etc.

5. CENTRE OF NATURE EXHIBITIONS

The aim of the project was to found a centre producing exhibitions and teaching equipment for areas of natural history and environment conservation, to modernise the Baltic Sea exhibit in the Estonian Nature Museum and the Zoological Museum of Tartu University.

6. INTERNATIONAL SUMMER SCHOOL OF YOUNG SEMIOTICIANS

The main idea was to integrate young scholars from Denmark, Sweden, Russia, Germany, Holland, Italy, Finland and Estonia. The backbone of the summer school was comprised of presentations by young semioticians who were given an opportunity to introduce the international audience to their main interest and research field in cultural semiotics and biosemiotics. The summer school was organized by Tartu University, a leading university in semiotics, continuing the work of internationally known scientist Professor Juri Lotman. **EEK 16 500.00**

7. ENCYCLOPEDIA OF SCHOOL MATHEMATICS

This reference book presents both notions and results from classical elementary mathematics, which are in the curricula of mathematics, and those which are necessary for teaching in specialized schools and in advanced study schools.

8. CENTRE FOR BRAILLE AND TALKING BOOKS OF THE ESTONIAN BLIND ASSOCIATION

The Centre aims at making information available and integrating blind people into society by working on publishing braille and talking books.

9. RECORDING ESTONIAN HISTORY OF PEDAGOGY

The project aims to study the field of education, to record interviews with outstanding educators, teachers and officials in the field of education and to store all the recorded materials at the Estonian Pedagogical Archive-Museum. At the same time, these materials are being used to make a series of programmes at Estonian Radio.

10. SAFER SEX WITHOUT ALTERNATIVE

General support for the AIDS-Information and Support Centre in order to carry out counselling, distribution of informational materials on AIDS and run an AIDS–24 hour hotline offering advice, counselling and teaching safer sex.

Teacher training programme on computer and internet usage initiated by a small rural school in South-Estonia.

12. MEDICAL BIOCHEMISTRY TEXTBOOK I

This will be the first original Biochemistry Textbook in Estonian. The project is co-funded by Estonian Science Foundation, Tartu University and Cultural Capital of Tartu.

13. INTERNATIONAL CONFERENCE 'GAME AND CULTURE'

The aim of the conference is to become acquainted with the results of research work carried out on the subject during recent years, to investigate the prospective position of children in society at the end of this century. The conference will be attended by several well-known specialists from Scandinavia, Russia, the Baltics and the USA.

14. TEXTBOOK 'DISCOVER YOURSELF AND THE WORLD OF YOUR OPPORTUNITIES'

The aim of the textbook is to help 14–15 year old children adapt to the circumstances of a rapidly changing society. It should help them make a choice between education, training and a job. The textbook contains a number of tests.

15. TRAINING PROGRAMME FOR THE PERSONNEL OF ASTANGU REHABILITATION CENTRE

The objective of the project is to create a rehabilitation system, working in real situations, through the assistance of which disabled people will obtain an optimum state of health and training opportunities as well working and participating normally in the development of society. **EEK 200 000.00**

16. REGIONAL ENGLISH TEACHERS TRAINING CENTRES

In order to expand the capacity of training English teachers, 10 regional English Teacher Training Centres were established in different regions of Estonia. The role of the centres is to improve the dissemination of information on changes in the educational system, to offer courses and workshops for teachers, to serve as a network through which trainers from all over Estonia and outside may be able to reach teachers at a regional level. The Centres will give teachers access to up-to-date teaching materials and technology. **EEK 480 000.00**

17. EDUCATIONAL THERAPY

Lecturers from the Scottish Institute for Human Relations learned about Estonian experience in teaching child psychotherapy with the aim of designing joint projects.

I. DEVELOPING THE CHAIR OF SOURCES AND METHODS OF HISTORY AT TARTU UNIVER-SITY

The purpose of the project is to develop a network of subjects which aim to provide future historians with the skills necessary for scientific research, as well as teaching subjects connected to the preservation, use and analyses of historical sources (archeography, paleography, historical metrology etc.). **EEK 350 000.00**

3. ANNUAL EXHIBITION

3rd annual exhibition of the SCCA, Estonia BIOTOPIA (Biology, technology, utopia) took place from November 22 to December 17, 1995 in the Tallinn Art Hall as well as in a number of galleries around the city centre. More than 30 artists took part in the exhibition, curated by Sirje Helme ja Eha Komissarov.

4. CONFERENCES

From November 23rd until the 25th Tallinn the International Interdisciplinary Conference on Computer Mediated Communication and Interactivity Interstanding – Understanding Interactivity took place in the National Library, Tallinn, organised by the Soros Centre for Contemporary Art Estonia and the E- Media Centre of the Tallinn Art University, in co-operation with SCAN, an interdisciplinary expertise centre for new media in Groningen, the Netherlands.

This was the first international conference organised in the Baltic region focusing on the social and cultural implications of the emerging interactive multimedia industry and the rapidly expanding global computer communication networks, from an interdisciplinary point of view. It brought together an outstanding international forum of artists, designers, architects, writers, philosophers and representatives of the media industry, to discuss the problems and potentials of the new digital culture. The conference was supported by a number of institutions, including Open Estonia Foundation, Estonian Ministery for Culture and Education, Baltic Computer Systems, Eltex, Concordia International University, National Library, Tallinn City Government, American Embassy, Finnish Institute, Centre Culturel Francais, Ministry of Foreign Affairs of The Netherlands.
